1. I have lived in the Waimate District for 20 years and St Andrews Village has been my home. We have experienced various proposals that Council has presented to the residents, regarding rubbish and recycling.
2. The 2020 consultation document is the best proposal that I have had to consider, OPTION A is the option that suits our budget and the way that recycling, waste disposal is best managed.
3. The disposal of green waste has always been a problem.
4. In my own situation I chip and screed my green waste and grass clippings to make compost, leaves and small twigs do not run thru my chopper, these are put in my rubbish bin. Weeds are not suitable for composting. The green waste bin will be very useful to us.
5. The recycling drop off located in the Village on our Village Green has been operating for a number of years. It has been a dumping ground for rubbish as persons from outside the District creates the waste problem, travelling camper vans, persons vacating properties. Material lying around creates an eyesore to the Village. When the bins are full loose paper and plastic is blown around the Village. A noise problem is also created with glass being tipped into the bins.
6. The proposal in OPTION A to have each household to have a recycling bin will eliminate the recycling drop off and hence remove the problems that I have referred to.
7. In support of OPTION A, I have the following recommendations to Council.
  - a. Close the recycling drop off in St Andrews
  - b. Relocate in the rural area, at the intersection of Blue Cliffs Road and Middle Road this will enable the rural areas to have drop off recycling.

<b>Do you have any other feedback in relation to rubbish and recycling in the Waimate District?</b>	In our personal situation our 80 litre rubbish bin only goes out once a fortnight where as the recycling crate goes out weekly. Where has the education been and policing of rubbish if contamination is a problem. When the current

waste collection started there were to be cameras on the rubbish trucks, is this no longer the case. How do we get rid of our food waste? We have a compost bin in the garden with active worms and other little breaking down creatures, where we never fill this container because the material we put in gets broken down as quickly as we put it in. This was my education those years ago when recycling was strongly promoted and saw what a woman was doing at Rakaia.

There appears to be where has this education of late come from council. As for the Green Waste what is wrong with this continuing with this service for those that want it, I know putting house hold scraps in green waste is a problem so that would still have to be outlawed. I notice around where I live a lot of older widowed people have gardeners who come in and mow the lawns and remove weeds so there is no need for them to have a green waste bin. Our green waste because we have a large section is taken away by the trailer load to rot down on the farm so I have no need for green waste bin. The waste plan Council is proposing looking out for the next 25 years is very optimistic when I read about the Southland Councils debate that is going on there suggesting that recycle material might have to go to landfill in the future. God forbid if we all have to have 5 large bins in our gardens as is being suggested as by Ministry of Environment.

We can not rely on other countries taking our waste, is it not time that some real effort is put into the theme of recycle reuse in our own country.

Having just returned from doing Meals on Wheels makes you realise how many older folk make up this towns population and the number that are widowed. How many times is it said one size doesn't fit all, it is so easy to have a blanket fit which for administration purposes is so easy, councillors and council staff try to think of the make up of this community, there needs and what they can pay for.

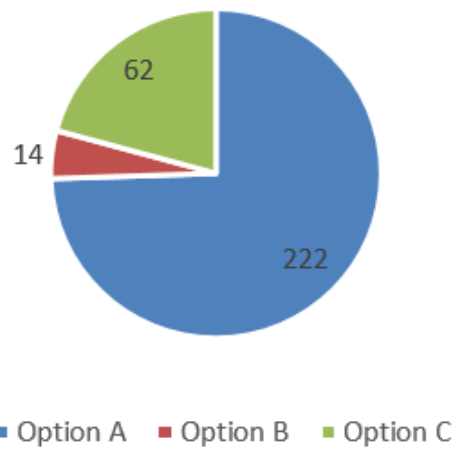

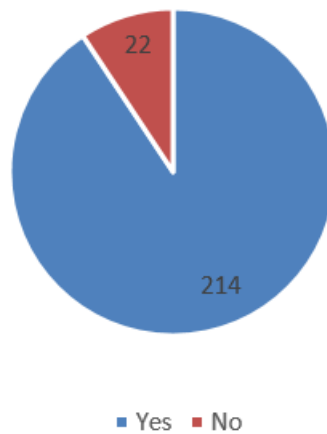
**STATISTICAL ANALYSIS**

7. In response to question 'a', public responses are:
  - f. Option A- multi-bin system: 73% (222/305 in favour)
  - g. Option B- 2 bin + glass: 4.6% (14/305 in favour)
  - h. Option C- current service: 20.4% (62/305 in favour)



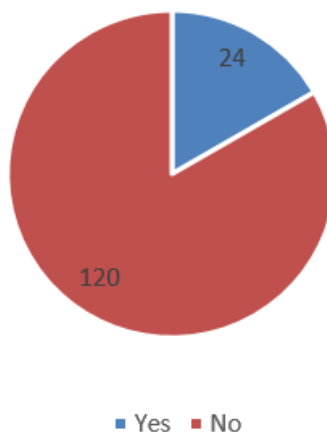
8. In response to question 'b', public responses are:

9. In response to question 'c', public responses are:

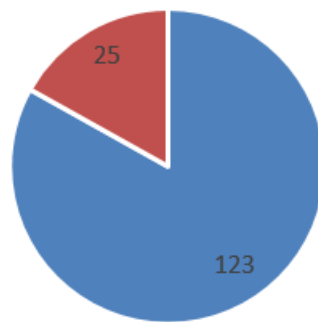
- k. Need more rural drop-off stations: 16.5% (24 in favour)

- n. Locations for current rural drop-off stations NOT appropriate: 17% (25 in favour)

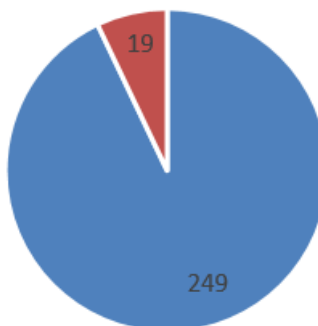

## Waimate District rubbish and recycling services

### We heard what you said

In 2018 we started the conversation with you about how we can improve our rubbish and recycling services over the next ten years. Your feedback helped form the basis of the Waimate Waste Management and Minimisation Plan for 2018–2028, which is available to read on [waimatedc.govt.nz](http://waimatedc.govt.nz).

The plan outlines the services to be provided, strategic direction and levels of service as well as highlighting the big issues that need to be addressed over the ten-year period.

### We want to improve our service

Over the last decade, since the introduction of our current rubbish and recycling system, there has been an increasing number of improvements in waste management services nation-wide.

Waimate District Council is committed to reducing the amount of rubbish sent to landfill, providing opportunities for people to recycle more, improving environmental outcomes and increasing the level of service which is modern and sustainable.

To achieve our goal we're approaching the contractor market together with Timaru and Mackenzie district councils for the provision of waste minimisation and management services. This could lead to environmental benefits, cost savings and increased levels of service for each district.

### Now is the time to talk about change

Our current rubbish and recycling contract ends **30 June 2021**

so now is the time to consider changes and review what level of service and management we want as a district before a new contract is awarded.

This will allow the successful contractor time to appropriately resource the new service and provide modern solutions with added innovation.

The initial term for the new contract will be 15 years with a possible five-year extension, depending on contractor performance.

There have also been legislative changes that require councils to improve waste management and to have a stronger focus on health and safety.

## We need to reduce our rubbish

In 1999, Council adopted an aspirational target of zero waste to landfill by 2015. The zero waste target was part of a national movement to help improve waste minimisation practices for New Zealand.

The Waimate District Council's vision for waste management and minimisation is:

**"A sustainable community that is able to reuse, recycle and recover discarded resources and minimise residual waste to landfill, while ensuring protection of public health and the environment."**

Along with the Waste Minimisation Act 2008, the New Zealand Waste Strategy goals and the target for zero waste, as a district we need to reduce the amount of rubbish we send to landfill, which will be better for the environment, help reduce costs to the community and extend the life of the landfill. One way to achieve this is to remove organics (green waste and food waste) from the waste stream.

## Reducing rubbish keeps costs down

All councils around New Zealand currently pay a Government waste levy for each tonne of rubbish sent to landfill. If councils don't reduce the amount of waste that is sent to landfill, they can expect to pay more in Government levies, which in turn have to be funded by communities.

Our Council currently pays the Government levy at a rate of \$10 per tonne of rubbish that is sent to landfill. By 2023 this rate could rise to \$60 per tonne, which will result in higher costs for the community, so reducing our rubbish and better recycling will help keep the costs down. Some of this waste levy fund becomes available for Council to introduce additional waste minimisation activities.

All rubbish in the Waimate District is currently sent to the Redruth landfill in Timaru. After recently updating their rubbish acceptance criteria, **green waste and food waste mixed in with rubbish will no longer be accepted at the Redruth landfill from 1 July 2021.**

## What are the options?

Waimate District Council has identified three options for consideration. All financial estimates are based on the information available at the time of producing this document. The final costs will be known once the contractor agreements have been finalised.

### Option A (preferred option)

This proposed service is based on a number of urban collection areas, which are outlined on the maps (pages 8–10). This service will be compulsory for residents within the defined areas.



This multi-bin option includes:

- 240 litre organics (green/food waste) bin collected weekly
- 240 litre recycling bin collected fortnightly
- 140 litre rubbish bin collected fortnightly
- Glass crate collected fortnightly

#### Advantages

- There will be an increased level of service provided for some members of the community
- Easy to separate rubbish and recycling
- Separation of rubbish reduces the cost of processing and disposal, and the amount sent to landfill
- Less risk of Government waste levy increases
- Better for the environment
- Cleaner streets as rubbish won't be blown from the recycling crate
- This service will be compulsory in certain areas, meaning that the increased cost can be spread over a larger ratepayer base
- Rubbish will be taken directly to Redruth landfill

#### Disadvantages

- Increased cost for some residents
- Extra space required to store the bins on residents' properties

**Estimated cost:** \$423 per dwelling for the 2021/22 year for the multi-bin service.

**How does this affect the community?** For some communities this service will be compulsory, so for those not currently receiving a rubbish and/or green waste bin, this will be a new service.

For rural communities there are currently some rubbish collection services and recycling drop-off stations available. This option will mean that in certain areas a new collection service of recycling, glass and organics will be provided.

### Why separate organics?

Organics (green waste and food waste) generally makes up more than a third of a typical rubbish bin. If we don't start separating our organics from our rubbish, we will no longer be able to use the Redruth landfill, resulting in ongoing increased costs to transport to another landfill farther away.

### Why separate glass?

Sorting glass from other recyclables reduces the risk of broken glass contaminating other items in the bin. It also means the glass can be colour-sorted at the kerb.

To compare what you are currently paying towards waste management, see page 7 for estimated rates applicable for your property.

Disclosure: Under this option it is assumed that anyone currently receiving a rubbish bin outside the compulsory areas will be included in the multi-bin system. There will not be the option to have any of the bins separately; however, anyone outside the compulsory areas who opts in for the multi-bin system can request additional bins (for example, an additional organics bin).

## Option B

This proposed service is based on a number of urban collection areas, which are outlined on the maps (pages 8–10). This service will be compulsory for residents within the defined areas.



This option includes:

- 240 litre recycling bin collected fortnightly
- 140 litre rubbish bin collected fortnightly
- Glass crate collected fortnightly
- Rubbish will be taken to the Waimate Resource Recovery Park for transport to another landfill other than Redruth
- Recycling would be processed at the Resource Recovery Park or contractor's nominated site
- Organic services would be provided at the Resource Recovery Park at a charge via the gate. A private service may be available between the resident and an independent contractor

### Advantages

- This service will be compulsory in certain areas, meaning that the increased cost can be spread over a larger ratepayer base
- There will be an increased level of service provided for some members of the community
- Cleaner streets as rubbish won't be blown from the recycling crate

### Disadvantages

- Less separation of rubbish will increase the cost of processing and disposal
- This option does not allow the use of Redruth landfill due to updated waste acceptance criteria, therefore we may have to pay more to transport rubbish to another landfill
- Likely increases to the Government waste levy

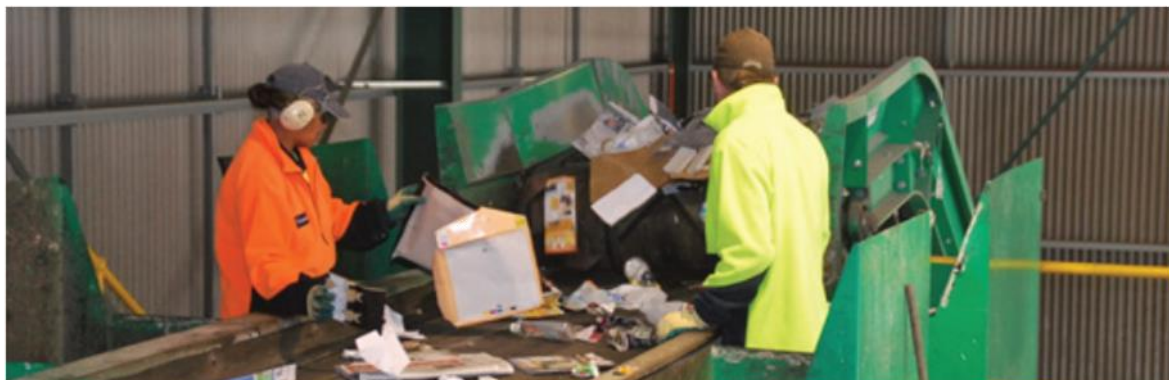
**Estimated cost:** \$415 per dwelling for the 2021/22 year for two bins and glass collection service.

### How does this affect the community?

For some communities this service will be compulsory, so for anyone not currently receiving a rubbish bin within a defined area, this will be a new service.

For rural communities there are currently some rubbish collections and recycling drop-off stations available. This option will mean that the service will be compulsory in certain areas, therefore a new collection service of rubbish, recycling and glass bins will be provided.

## Option C

This option is based on the current service provided, except for the use of rubbish bags.



This option includes:

- 80 litre urban rubbish bin collected weekly
- Recycling crate collected weekly
- 240 litre rural rubbish bin collected fortnightly
- Rural recycling drop-off stations
- Organic services provided at the Resource Recovery Park at a charge via the gate. A private service may be available between the resident and an independent contractor

### Advantages

- Continuity of service
- Optional rubbish bin service

### Disadvantages

- Recycling crate is only 60 litres and without a lid; rubbish can be blown out
- No Council-serviced organics bin
- Weekly collection of rubbish bins encourages poor recycling
- Less separation of rubbish will increase the cost of processing and disposal
- This option does not allow the use of Redruth landfill due to updated waste acceptance criteria, therefore we may have to pay more for transport of rubbish to another landfill
- Likely increases to the Government waste levy
- If you do not have a bin, you will need to take your own rubbish to the landfill

### Estimated cost per dwelling for 2021/22 (dependent on location)

- 80 litre urban rubbish bin – \$212
- 60 litre urban recycling crate – \$175
- 240 litre rural rubbish bin – \$318
- Rural recycling drop off service – \$88

**Council rubbish bags will no longer be available under any of the proposed options after 30 June 2021. This will help improve the health and safety and efficiency of our contractor.**

The cost of operating the Resource Recovery Park is partially covered by fees and charges (for rubbish taken directly to the Resource Recovery Park), with the remaining funds covered by Civic Amenities Rates which all ratepayers contribute to. For all options presented (A, B and C) the cost of operating the Resource Recovery Park is estimated to reduce and has been incorporated into the sample of changes above.

### Weight-based charging for the Resource Recovery Park

At the Waimate Resource Recovery Park we're moving from volumetric charging to a weight-based charging system prior to the contract changing in July 2021. This will ensure a fair and equitable charging mechanism for users of the Resource Recovery Park.

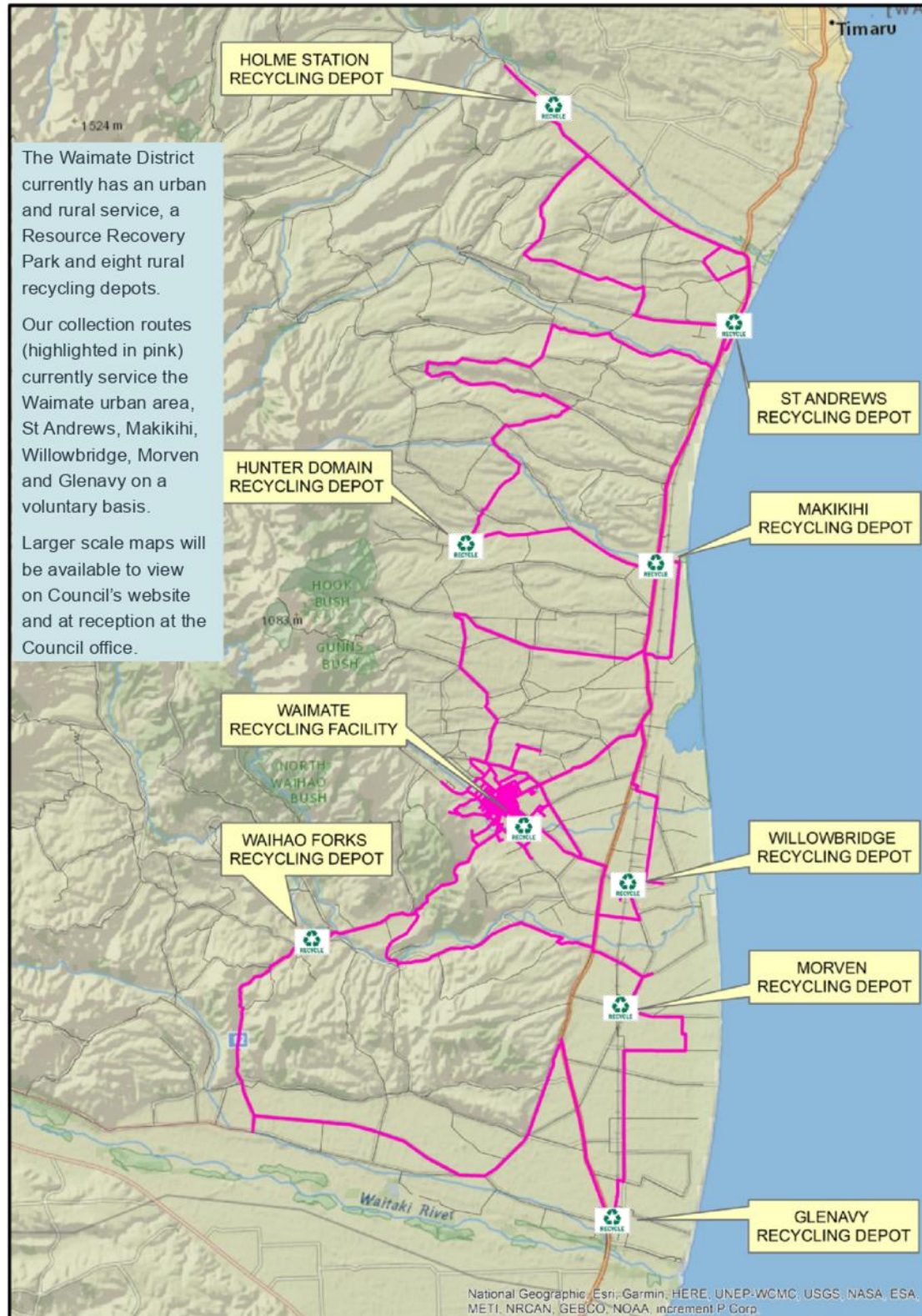

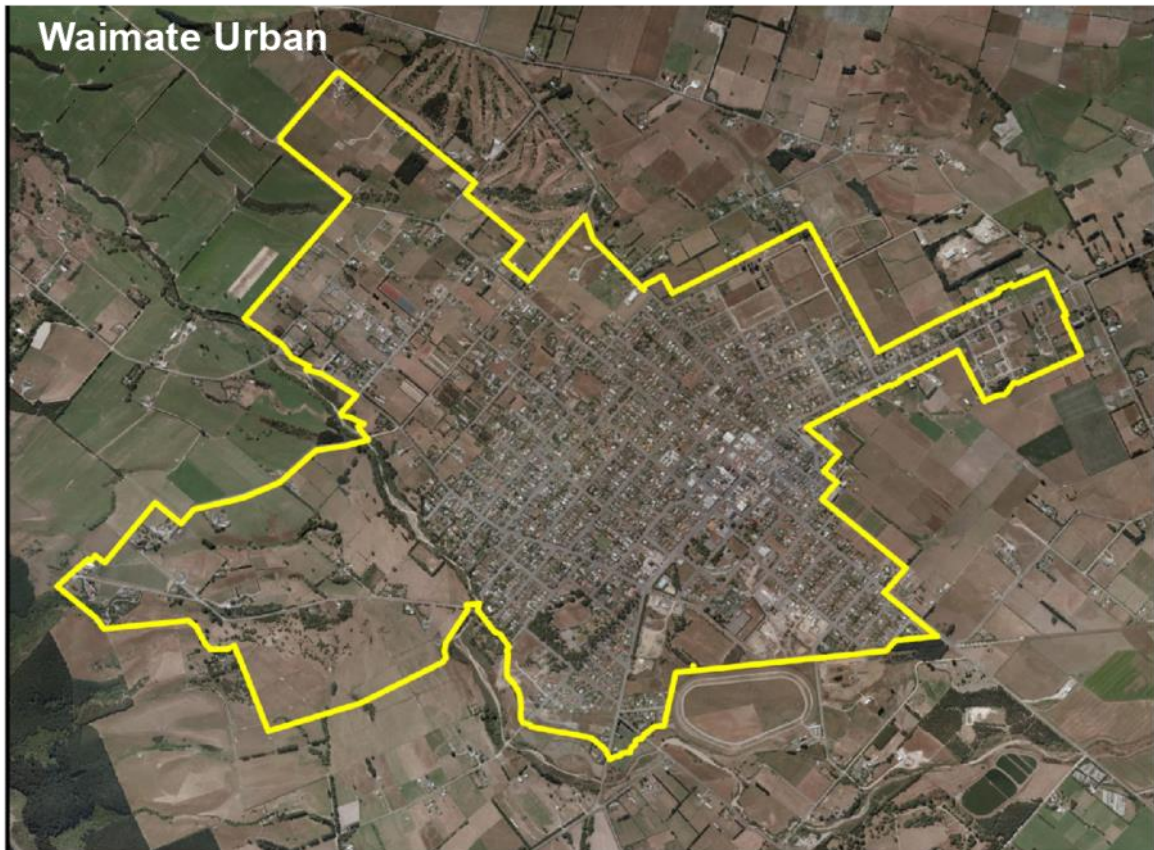

**Waimate urban:** The proposed Waimate urban collection route will service a total of 1,460 dwellings, including 297 dwellings that were previously not serviced. This includes commercial and business.

**Glenavy:** The proposed Glenavy collection route services a total of 58 dwellings, including 35 dwellings that were previously not serviced.

You are penalising households who are doing the right thing (reducing waste) and you are making it compulsory for them to subsidise those that aren't.</p> <p>Page 7 refers to the weight based charging for Resource Recovery Park. The document says this will "ensure a fair and equitable charging mechanism for users". Why is Council not considering the same "fair and equitable charging mechanism for the Options A &amp; B? What does this mean? If you do not need a red bin and/or a green bin then you can opt out. The allocation and charging of red and green bins should NOT be compulsory. Providing more bins does not necessarily translate to less waste. What should we be doing? Helping people to compost themselves. I have lived in places where Councils have provided free compost bins to residents that want them so they can compost at home.</p> <p>Under Option A the \$265-\$342 annual increase to urban and rural households currently receiving a recycling crate only is SIGNIFICANT. The collection service for this area should remain voluntary, as it is now. Councils rubbish and recycling services consultation document identifies green waste and food waste as the prime problem, in future needing to be separated from the landfill waste stream, as not being accepted by Timaru district's landfill, so in principles, the idea of extending the wheelie bin system to include a separate bin for organics, (as per option A) is fair enough, BUT in the case of the dwellings in the Willowbridge settlement area, council seems to have looked at these properties, and because they look like a street, decided to treat them in the same way as the Waimate urban area. Council needs to look again, each of these dwellings are sitting on 5 acres of land. People living in these dwellings are perfectly able to dispose of their food waste and their green waste by sustainable methods such as composting, worm farms, feeding food waste to cats, dogs, chickens and mulching and by properly managed occasional small contained fires. In the case of my mother, who owns one of these properties, she recycles assiduously, has a compost pile, and a companion animal and occasionally will have a small contained fire to dispose of larger garden material. The only waste that she needs to take to landfill consists of mainly non- recyclable plastics, and the occasional broken or unwanted small item made of mixed materials. This landfill contribution will amount to no more than 5 bags per year, which will cost her \$7 each when she takes them to the landfill, a grand cost total for her annually of \$35. Council's consultation document identifies that under the proposal to make collection compulsory for the Willowbridge settlement dwellings her cost will rise by \$342 annually. This is patently unfair, because Willowbridge settlement residents, can and do as I have explained, competently and sustainably dispose of all of their food waste and green waste on their own properties. Surely council should be encouraging all residents to do this!</p> <p>Council's proposal to make collection services compulsory for properties in the Willowbridge settlement area is poorly thought out, and amounts to an unwarranted revenue grab. Council must leave collection services for the Willowbridge settlement area on a voluntary basis as it is now and find another way to balance it's rubbish and recycling budget.</p> <p>On a more personal note, my mother lives alone and her only income is National Superannuation, this is a position that council should recognize is the reality for many Waimate district residents. The imposition of an additional cost of \$342 per annum (oh, yes of course, less the \$35 she will save on those 5 bags she currently takes to landfill) is highly significant and upsetting for her.
