## 4.1 MINUTES OF THE LOWER WAITAKI SOUTH COASTAL CANTERBURY ZONE COMMITTEE MEETING HELD ON 21 NOVEMBER 2018

#### **COMMITTEE RESOLUTION 2018/33**

#### Amendments:

Declaration of Interest: Daniel is now a Councillor on the NZ Fish and Game Council.

General Business: John Benn DOC comment's on Fit for Future – Merging Contaminants: European Community had recently voted to put a very strict limit on the amount of cadmium in phosphate fertilisers (60ppm or 60mg/L). This could have economic and environmental implications in the future, as many countries followed, or were influenced by European environmental standards. Much of New Zealand's imported phosphate fertiliser comes from North West Africa, which has some of the highest cadmium levels of all phosphate fertilisers.

#### **Matters Arising:**

- Waihao Box: Bruce Murphy noted the stumps have been removed.
- Single Extractions: The Chair highlighted concerns about the build up of single at the
  Kurow, Otiake and Otekaieke riverbeds. This is affecting the riverflow, and cycletrail and
  potentially local businesses connected to the cycletrail. Cr Scott is to raise the consenting
  process of shingle extraction with the Chief Executive and River Engineering Manager. A
  meeting with extractors may also be helpful. There is a meeting this Friday at 1pm at the
  Waitaki Bridge Hall Rating Group and would be an ideal place to raise concerns. ACTION
  POINT The Facilitator was asked to arrange a presentation on Shingle Extraction.
- Refresh Project: The new Committee Members of the Zone Committees will be ratified at
  the meeting of ECan tomorrow (13 December 2018). The Facilitator reported that new
  members can be co-opted on to the Committee for specific purposes, i.e., because they live
  in an area of focus and don't have to go through the refresh process but may need to be
  ratified in some way with Councils. This will be look at more fully in the New Year. ACTION
  POINT The Facilitator was asked to invite Mark Kingsbury and Emily Anderson to the first
  meeting in 2019.

3 ELECTION OF CHAIR, DEPUTY CHAIR AND REGIONAL COMMITTEE REPRESENTATIVE

#### **PURPOSE**

1. For the Lower Waitaki South Coastal Canterbury Zone Committee undertakes the election of:

- a. Committee Chair
- b. Deputy Chair
- c. Regional Committee Representative

#### **BACKGROUND**

#### Chair

- 2. Each year, the Committee will appoint a Chair from its members by simple majority. There is no limit on how long a person can be in this position. As a Committee member, the Chair shares the same responsibility as other Committee members. In addition to this the Chair has the following roles:
  - i. Chair Zone Committee meetings with all the commonly recognised authority of that position. The Chair may have the Zone Facilitator facilitate meetings and workshops of the Committee; and
  - ii. Speak on behalf of the Committee and act as an advocate for it, including taking primary responsibility for interaction with the media and representing the Committee at meetings with external parties.

#### **Deputy Chair**

3. Each year, the Committee will appoint a Deputy Chair from its members by simple majority. There is no limit on how long a person can be in this position. The Deputy Chair exercises the same roles as other members, and if the Chair is absent or incapacitated, the Deputy Chair must perform all the responsibilities and duties of the Chair (as above).

#### **Regional Committee Representative**

- 4. The Zone Committee appoints a representative to the Regional Water Management Committee.
- 5. This appointee may be the Chair of the Zone Committee or another member appointed by the Committee from its membership.
- 6. The Zone representative on the Regional Committee will:
  - i. Speak on behalf of the Zone Committee and act as an advocate for it at Regional Committee meetings.
  - ii. Keep the Zone Committee well informed on the activities and deliberations of the Regional Committee.

## Process to Elect of Chair and Deputy Chair (ref. Schedule 7 clause 25, Local Government Act 2002)

7. For the election or appointment of the chairperson and deputy chairperson, a local authority or a committee (if the local authority has so directed) must determine by resolution that a person be elected or appointed by using one of the following systems of voting:

#### System A:

- a. Requires that a person is elected or appointed if he or she receives the votes of a majority of the members of the local authority or committee present and voting; and
- b. Has the following characteristics:
  - i. There is a first round of voting for all candidates; and
  - ii. if no candidate is successful in that round there is a second round of voting from which the candidate with the fewest votes in the first round is excluded; and
  - iii. if no candidate is successful in the second round there is a third, and if necessary subsequent, round of voting from which, each time, the candidate with the fewest votes in the previous round is excluded: and
  - iv. in any round of voting, if 2 or more candidates tie for the lowest number of votes, the person excluded from the next round is resolved by lot.

#### System B:

- a. Requires that a person is elected or appointed if he or she receives more votes than any other candidate; and
- b. Has the following characteristics:
  - i. there is only 1 round of voting; and
  - ii. if 2 or more candidates tie for the most votes, the tie is resolved by lot.

#### RECOMMENDATION

That the Lower Waitaki South Coastal Canterbury Zone Committee elect the Chair, Deputy Chair and Regional Committee representative for 2019.

#### **Zone Map**

2. The Committee requested a detailed map of the zone, which would show details including streams. A map of the zone with that much detail becomes quite large so ECan GIS staff created a map in on the web site "Canterburymaps". #### **Noho Marae**

- 3. An invitation was emailed recently to Zone Committee members to participate in the Noho Marae experience at Waihao Marae on Thursday 21st March and Friday 22nd March 2019. There are still some places left if members of the Committee are interested.
- 4. The purpose of the overnight marae stay is to provide people working with Environment Canterbury and Ngāi Tahu, with an understanding and appreciation of Māori traditions and culture through experiencing hands on learning.
- 5. In accordance with the Māori way of life, the two-day stay will have an emphasis on sharing and will involve sleeping in close quarters, eating meals together, engaging in discussion and being involved with the day to day activities on the marae with the hau kāinga home people.

#### **Treaty of Waitangi Workshop**

6. ECan are considering holding a two-day Treaty of Waitangi workshop in Timaru to make it easier for Zone Committee members to attend. Please indicate if you would be interested in attending and your preferred time of year.

#### **Course Description**

- a. Realise that the Treaty is the fundamental relationship between Maori and the Crown
- b. Understand that contemporary treaty issues and Maori/pakeha relationships cannot be understood outside the context of history
- c. Develop your own personal opinion
- d. Be able to approach issues emanating from the Treaty with confidence
- e. Understand the colonisation of NZ
- f. Make connections between contemporary treaty issues and historical events
- g. Deepen understanding of the impact of the economy and policies on Treaty issues and personal wellbeing
- h. Develop a level of critical analysis of public debate
- i. Be aware of the effect that culture and racism have on yourself and others

- j. Nurture your Treaty consciousness
- k. Be empowered to develop and maintain the Treaty relationship appropriate to your area of work

#### **CWMS Fit for Future Update (from Chris Wikstrom, Project manager)**

- 9. The Fit for Future project wishes to thank the Zone Committees for their feedback and advice on the draft 2025 and 2030 goals.
- 10. Considerable effort has been applied to fold in the feedback received on the draft goals which are now largely complete, although some refinement is still required. The draft goals have been presented to the Goals Working Group, Chief Executives' Forum, Regional Committee and Mayoral Forum.
- 11. Regional work programmes to implement the draft goals are in development. These work programmes are high-level actions that are required to deliver the goals. The project team is now focussed on identifying the scale, prerequisites and indicative ownership of the work programmes.
- 12. We look forward to updating the Zone Committees in March.
