## 5.5 ZONE DELIVERY QUARTERLY REPORT

Zone Manager Chris Eccleston gave a presentation, and tabled his report.

The Committee asked Chris to supply this report prior to the Zone Committee meeting to allow members to read it in advance because of its importance to the Zone Committee. Chris advised that the timing on the reporting cycle makes it difficult to achieve this but it would be possible to delay the report until the subsequent meeting to allow for this. The Committee said they would be happy to receive the report via email even a day or two before the meeting. Chris will look into what is possible.

A rubbish problem was identified at Wainono, as there was currently no bin there. Suzanne Eddington suggested the Waihao Marae may be able to provide a daily rubbish collection service and will advise.

A new shared role of Compliance and Enforcement Officer (funding 20% ECan, 80% Waimate District Council) will soon be starting at the Waimate District Council under a Memorandum of Understanding with ECan.

There is work being done on rationalising and unification of water samples. The first meeting was well attended. The aim is to provide clear process for people taking water samples for consistency and to reduce total number of samples being taken. This work is being driven by Waitaki Irrigators Collective with support from ECan.

There was discussion around the lack of level of compliance monitoring and enforcement staff within Environment Canterbury, and constant changeover of staff. This will be discussed further at the next meeting.

It was identified there were many rural (catchment) groups and farmers (goodwill) wanting to do the right thing, but there is a need for facilitators.

It would be helpful if the Territorial Authorities were more supportive.

The Chair commended ECan staff generally for their commitment to their roles.

## 5.4 CONSENT COMPLIANCE MONITORING AND INCIDENT RESPONSE - QUESTION & ANSWER SESSION

The Committee asked for this to be brought to the next meeting to allow for more time for discussion.

## 5.6 WILDING CONIFER CONTROL

Biodiversity Manager Graeme Sullivan gave a presentation on the Wilding Conifer Control Programme.

## 5.7 GENERAL

#### **DoC Ranger for River Projects**

John Benn advised DoC are allocating financial reserves to restore rivers around country. Some of this funding is coming to Canterbury. A ranger has been appointed to the Geraldine office (Brad Edwards) to look at projects in the Lower Rangitata and Waitaki.

## Purpose

To agree high-level priorities to support the development of the Zone Committee's work plan for the next one to two years by:

- 1. Sharing knowledge between committee members and ECan staff
- 2. Agreeing the most important issues for each catchment area
- 3. Agreeing high-level solutions/actions in each catchment or across catchments
- 4. If time permits, prioritise actions

## Background

The Lower Waitaki Zone Committee is transitioning from a time of intensive community engagement and authoring the ZIP and ZIPAs to focussing on "on the ground" implementation of the CWMS.

Plan Changes 3, 5 and 7 (currently notified) apply to various parts of the zone. While the Committee to some extent has a role in educating the community about the plan changes it is primarily the role of ECan to ensure compliance. The Zone Committee, however, with its strong connections into the local community, has the ability to identify, socialise and leverage community and industry support to encourage and support non-statutory actions towards the CWMS targets.

This workshop focussed on identifying the high-level non-statutory opportunities and actions the Zone Committee might undertake over the next one to two years.

## Approach

The Workshop opened with everyone reading a Karakia.

Dave briefly reminded the committee of the CWMS desired outcomes, principles, priorities and the 10 targets and discussed what we hoped to get out of the workshop.

Bruce Murphy highlighted the statement below from the ZIP, stating that for him this summed up everything about why we are here as a committee.

## Ko te wai ko te mauri o te whenua ka takoto mai nei. Kia ora ai ngā mea katoa ki uta ki tai e. Water is the lifeforce of the land that lays here. For the wellbeing of all things from the mountains to the sea.

## General

The group discussed each catchment in turn. There were common themes/ideas listed below:

- Review priorities/plans
  - o 3 year cycle
  - Scheduled into yearly meeting plans. E.g. this month focus on Hakataramea.
- Critical Source Area (CSA) mapping
  - Seen as very useful to get granular detail on where individual farmers can really make a difference
- Achieve much more by engaging industry, government departments, and individuals. e.g:
  - o Beef and Lamb
  - o Territorial Authorities
  - Catchment Groups
  - Dairy NZ
- Strong Relationships are key
- Advocacy and Education
  - Youth engagement
  - o Community events
  - o Link into existing e.g. Strawberry Fair or create new
- Waitaki Iwi Management Plan now published

## Waihao Wainono

Dear Committee Chair,

#### **RE: CONFLICTS OF INTEREST ON THE ZONE COMMITTEES**

- As you will no doubt be aware the Auditor General has revoked the declaration made in 2018 (the 2018 declaration) relating to section 6(1) of the Local authorities (Members Interests) Act 1968. This was done as a result of legal proceedings lodged by Forest & Bird in the High Court.
- 2. I thought I would take this opportunity to advise you of Forest & Bird's views of this issue. Please can you ensure that this letter is circulated to members of the committee that you chair?
- 3. Section 6(1) gives effect to the principle that those who take a public position should not use that position to advance their own pecuniary interests. It does this by prohibiting those with a pecuniary interest from participating in discussions or voting on matters where they have a pecuniary interest.

## 6 Member of local authority or committee not to discuss or vote on question in which he has pecuniary interest

(1) A member of a local authority or of a committee thereof shall not vote on or take part in the discussion of any matter before the governing body of that local authority or before that committee in which he has, directly or indirectly, any pecuniary interest, other than an interest in common with the public.

- 4. A failure to comply with s 6(1) is an offence.
- 5. The 2018 declaration provided an exemption from s 6(1) to those on the zone committees and the regional committee (the committees). The effect was that members of the committees were able to discuss and vote on matters where they had a pecuniary interest. It allowed shareholders in companies to discuss and vote on matters that directly touched their financial interests, such as the review of consent conditions. Directors and Chief Executives were able to participate in discussions and vote on matters critical to the companies they directed or managed.

- 6. Forest & Bird considered allowing such blatant conflicts of interest were not appropriate. This concern was exacerbated by the makeup of many of the zone committees, which did not reflect the community but instead were dominated by farming and irrigation interests. We considered this was a significant contributor, along with the loss of elected representatives and appeals to the Environment Court, to the recent drastic decline in water quality and quantity in Canterbury.
- 7. The revocation of the 2018 declaration means that s 6(1) applies in full. Committee members must not participate in discussions or vote on matters where they have a pecuniary and they can be prosecuted if they do.
- 8. Forest & Bird will remain vigilant. We will be reviewing committee agendas and minutes to determine if there have been any breaches. If we come across any breaches, we will refer these to the Auditor General with a request that they be investigated and, if proved, prosecuted.

#### PURPOSE

1. To agree to the Zone Committee actions to support water quality improvement in the Waihao Wainono Catchment.

#### BACKGROUND

- 2. Refer to the *Lower Waitaki South Coastal Canterbury ZIP* and *South Coastal Canterbury ZIPA* recommendations and the high-level priorities for the Waihao Wainono Catchment as identified at the August 2019 Zone Committee workshop shown below.
- 3. Main issues are Sediment and Phosphorus
- 4. Influence in the non-statutory space recommended as many farms come under permitted activity.
  - a. Project approach (similar to approach used in Hook catchment) is recommended as most effective
  - b. Drivers for change:
    - i. Probable tightening of National Environment Standards in near future
    - ii. Plan review 2025
    - iii. If TLI doesn't improve, it could mean tighter restrictions.
- 5. Work closely with Waihao Wainono Catchment group e.g.
  - a. Black Hole
  - b. Community Meetings
  - c. Field days and workshops
  - d. ZC members to attend/have closer relationship
- 6. Augmentation of Wainono Lagoon
  - a. Parked but not forgotten (ECan science and modelling currently being done)

## RECOMMENDATION

That the Zone Committee discuss and agree on detailed priorities for the Waihao Wainono Catchment.
