INFORMAL NOTES TAKEN AT MEETING ON WAITAKI EROSION AT GERT VAN'T KLOOSTERS ON FRIDAY 12 JUNE 2020

A meeting was held at Gert Van't Kloosters property to look at the river erosion issue that has arisen on his property and also on other sites adjacent to the river. The meeting was short notice and some committee members were unavailable but thank you to those and the ECan staff that did attend. Waimate Cr Sheila Paul and Waimate Deputy Mayor Sharyn Cain also attended

Gert outlined the scale of land he had lost and showed where he had just recently spent 60k with a dozer just to divert one of the main streams of the river away from his property.

People attending seemed surprised by the scale of the works that private land owners were having to undertake to protect their land.

Two key points coming out of the meeting were:

- 1. How to slow the loss of land and infrastructure through erosion and how it is funded in the short time; and
- 2. The need for a rating review to look at how rates are used to maintain the river

After the meeting held in Kurow for adjacent land owners, a River Liaison Group was formed. Daniel Isbister from our Committee is a member. The group intends to look at how to deal with the two points stated above, and to form a view of how Ecan are monitoring the Meridian Consent.

Of particular interest to this group is:

- Condition 1 which states The Grantee(Meridian) shall exercise this permit in conjunction
 with all other rights which the Grantee holds in connection with the generation of electricity
 with in the Waitaki River system, in such a manner as to minimise, as far as possible, any
 adverse effects of the rights on the Waitaki River system; and
- Condition 7 which states The Grantee(Meridian) shall:
 - i. take such precautionary measures which the Canterbury Regional Council may require to prevent damage from erosion which is likely to occur as a result of the exercise of this permit and,

ii. make such remedial repairs which Canterbury Regional Council may require to remedy damage from erosion which occurs as a result of the exercise of this permit

The River Liaison Group will be looking for a recommendation of support from us to ensure these conditions of consent are being monitored correctly by Ecan

Including contracts in which the Member or their spouse is a partner, a company of which the spouse is a director and/or holds more than 10% in shares, or a Trust of which the Member or their spouse is a trustee (noting that no committee member should be a party to a contract with Environment Canterbury or the relevant TLA if that value is more than \$25,000 per annum)

Hello Kate,

You are aware of the successful restoration of the Kurow Island from a closed land fill and wasteland to a recreational and ecological area that benefits people, wildlife and the environment. The plantings, notice boards at the entrance, display bridge and magnificent new shelter, easy accessibility to the river and jet boat ramp attracts many visitors.

Complementing our Island is the development and restoration of an overgrown and inaccessible valuable wetland on the South Bank ,with its own distinct ecosystem characteristic vegetation and aquatic life. Over the past 5 years a group of volunteers have physically cleared the black berry and overgrowth to expose this magical area with a 1 kilometre track allowing accessibility and undertake further plantings.

Signage Funding Project 2020

A collaboration between Kurow Island Group and Kurow Wetland Group



Re: An update on the progress of the applications to replace the Mining Rights on the Lower Waitaki Tributaries

The purpose of this letter is to provide the Zone Committee with an update on the consent applications to replace the mining rights ("deemed permits") that are due to expire on 1 October 2021. Affected mining rights consent holders are members of Waitaki Independent Irrigators Incorporated (WIII), hence WIII's involvement.

It appears evident from previous correspondence and conversations, that ECan staff are incorrectly of the opinion that several mining rights holders intend to outright swap these mining right consents for Kurow Duntroon Irrigation Company (KDIC) scheme water. This is not the case and it is hoped that this letter will provide further clarity around the work that has gone into the consent applications.

The Mining Rights Group is represented by Susie McKeague, McKeague Consultancy. Susie has provided the below details on proceedings to date.

- Contacts within ECan: Three years ago Zella Smith was nominated as the contact
 person with ECan. She has remained the primary contact with the Mining Rights
 group. The ECan Science Team have also been communicating with the group to
 gather information and share results. Most recently Duncan Gray and Graham
 Clarke have shared ecology and quality work. Jen Dobson has also discussed the
 recent ECan hydrology flow work with the group.
- 2. Rivers with mining rights: Awakino, Kurow, Otiake and Otekaieke.
- 3. Lodging the applications: The application will be lodged by the end of 2020. The expiry date is Oct 2021, six months ahead of then with a little leeway to avoid any Sec88 non acceptance brings the deadline to the end of 2020. The group were waiting for the hydrology gauging work to demonstrate three (Otiake, Otekaieke and Kurow) of the streams dry up naturally. That work has been completed and now they are hoping to have Moeraki Rūnaka on site to discuss any concerns they may have before lodging.

- 4. Fish and Game and DoC involvement to date: In 2018 the group completed site visits with DoC and Fish and Game. Iwi were invited but were not able to make it. Following that visit, a day of electric fishing of the sites with the farmer's expert and Fish and Game and possibly DoC was completed.
- 5. ECan science/gauging work: ECan completed gauging in 2018 and 2019. They have a prepared a draft report that was due to be presented to Council. The farmers have done some drone work during the dry times as well so they could see where the dry stretches were at different times. Jen Dobson from ECan discussed the hydrology at a recent Zoom meeting we held. The farmers have understood the creeks dry up naturally but needed good science to demonstrate that. In fact at least one of the creeks was dry in early August when no abstraction was occurring. Under the current plan the minimum flow would be MALF, which is zero. That minimum flow wouldn't provide any protection for instream values at the intakes. So the farmer group has also been focusing on the stretches of the creeks that may benefit from a residual. Awakino doesn't dry up naturally and has a high minimum flow for trout, which also needs to be better understood.
- 6. Moeraki rūnaka involvement: The Rūnaka have visited the area but not the intake sites. The group has had a standing invitation with Moeraki Rūnaka for two years. The group were hopeful they would have been able to visit sooner than now so we could incorporate any concerns into the application proposal. The farmers have also offered to manipulate the flows when they were on site if the Rūnaka members found that useful. Gail Tipa from the Moeraki Rūnaka has indicated the end of August as a date they will visit but knowing the demand on any organisation or individual in the RMA space right now particularly lwi we understand their inability to attend. We have been reluctant to lodge without lwi engagement.
- 7. **KDIC** scheme water as a replacement for mining rights water: There is no plan to swap any mining right water for KDIC water. That concept has never been discussed at any Mining Rights meetings. **ALL** mining rights holders are using and rely on their water and intend to replace those permits. They are aware that the effect of the abstraction on the streams will need to be assessed and that may result in some adjustments to surety of water in low flows times due to potential residuals and intake structure redesigns. To the best of my knowledge right now: Two or three of the mining rights holders have KDIC shares. In two cases those shares are used on the lower lying land and have been irrigating with KDIC water since before the upgrade of the scheme. One water user has purchased KDIC to provide an option of irrigating the lower land on the farm with the shares when the creek water is reduced due to environmental changes. The prohibitive cost of pumping the water higher up the valleys will be explained in the application.
- 8. Fish screens: The group have raised their concerns about fish screen requirements that are not commensurate with the risk to instream life with ECan. Dave Moore committed to checking the suitability of a locally designed screen on Goldwyn Station at a Zoom meeting on 28 May 2020. Please note that WIII is a financial contributor to the Irrigation NZ Fish Screen Special Purpose Group and WIII is currently awaiting results from the three trials currently underway and hope that the outcomes will provide some practical guidelines, however there are some general concerns around this.

9. The consent holders are listed in Table 1. The consent numbers are still being finalised as there is a little confusion in the Otiake. All those permits being exercised now will be included in the application. The full volume on most of the permits is not being replaced. Only the water the irrigators have a history of use for will be replaced. Mining Rights traditionally have very large volumes that are not often used. In the application, the KDIC shareholders will demonstrate that they are efficiently watering their farms and that there is no over irrigation.
