Desktop analysis from the Hydrologist indicates there should be sufficient capacity to augment the Hook-Waituna schemer from the Otaio Scheme. Further work will be on hold pending the result of the Otaio Bore Redundancy project below. Investigations into a 12km pipelines to augment Hook from Otaio have resulted in a Feasability & Preliminary Design cost that trigger Procurement protocols. Procurement Planning underway. The landowner had other activities that would be impacted, if the bore became a community drinking water supply. Further work needs to be carried out on options for taking and treating water at Waikakahi. This includes a reduction in the total number of connections within the supply and potentially source water obtained from Waihao Downs Irrigation Scheme. Waugh Infrastructure has been engaged through funding provided by the WSE Transition process to produce an options report and a preferred solution. Likely to be rebudgeted for 2025/26 at \$2.9M
